Attendees will gain knowledge of chemical characteristics, the effects to exposure and how to properly use personal protective equipment.	Description: This course is designed to provide you with some basic knowledge of leak detection practices and correlation methods. Students will be instructed in the basics and background theory of leak detection to better utilize basic correlation techniques for distribution and collection systems. Participants will learn various methods available to identify and find leaks. A variety of equipment will be demonstrated and used to aid students in accurately pinpointing leaks in all types of pipe materials.
